# Site Inspection

Weather: 14°C, sunny and windy.

Environment Officer Joshua Crisp arrived at site and met with the Site Director and the Commercial Manager.

# **Aluminium Processing**

The operators have recently submitted a planning application to install new aluminium processing plant to increase the recyclability of aluminium on site and within the U.K., and to save on shipping exportations. It was discussed with the operators that once approved and built that the Environmental Management System and the Fire Prevention Plan would need to be updated to include the new processes. Dust emissions have been considered and should not be an issue due to the nature in which the new plant tears the metal rather than shredding.

#### Fire Prevention Plan

The Fire Prevention Plan was discussed on site and will be followed up separately to this report.

#### **Requested Documents**

Waste Transfer Notes and Consignment Notes were requested during the inspection and have since been sent to us.

The latest Environment Management System was also requested and sent. It is comprehensive and reflects accurately the processes that were seen during the inspection.

# **Summary**

Overall the site was tidy, and there were no issues noticed with regards to noise, pests or dust during the inspection.

**Total non-compliance score for this inspection – 0 CCS points,** which makes you a **Band A** operator and means your subsistence fee charges will be **reduced by 5%** of the regular charge for next year.
