# What personal information do we hold?

The services above may use some or all of the personal information below:

- Names, address and contact details
- Date of Birth
- Employment
- Financial Details
- Licences and permits held
- Goods and services information
- Case file information
- Business Activities

We get most of this information from you, but we may also get some of this information about you from the police, other local authorities, other government agencies, e.g. Driver Vehicle Licensing Agency DVLA, Planning Inspectorate and via evidence procured as part of a waste crime investigation.

## How do we use your personal information?

We use your information to:

- Handle your query
- To detect and prevent crime or fraud

#### Who else might we share your personal information with?

Sometimes we may need to share your information, but we will only do so where it is necessary or required by law. We will only share the minimum information for each circumstance. We may sometimes need to share some of your personal information with:

- Police
- DVLA
- Environment Agency
- Other Government bodies

## How long will we keep your personal information?

We will only use your personal information whilst delivering the service to you and to deal with any questions or complaints that we may receive about this unless the law



requires us to keep it for a longer period. In practice, this means that your personal information may be retained for:

# Will my personal data be held or used outside of the United Kingdom?

No personal information is routinely sent or held outside the UK. Should the transfer of personal information outside of the UK become necessary, it will only take place if permitted by law, and then only where there are appropriate safeguards in place to protect the data.
