

NOTICE OF PUBLICATION OF REVISED ELECTORAL REGISTER ON 2 JANUARY 2025 AND AMENDMENTS TO POLLING DISTRICTS & POLLING STATIONS

NOTICE IS HEREBY GIVEN that the Electoral Registration Officer for Castle Point Borough Council has delayed publication of the revised electoral register due to the UK Parliamentary General Election taking place on 4 July 2024 and to enable changes to be made to some of the Council's Polling Districts following a review of Essex County Council's (ECC) electoral arrangements by the Local Government Boundary Commission for England. Changes to Polling Districts

As a consequence of the ECC boundary changes it has been necessary to split polling district AY1 (Thundersley South Ward) as follows:

Due to the changes to the boundaries it is also necessary to make amendments to the allocated polling stations of those electors affected as follows:
