



**Notice to Occupier**  
**Section 46 Environmental Protection Act 1990**  
**Receptacles for Household Waste**

1. Castle Point Borough Council (the Council) can require residents under Section 46 of the Environmental Protection Act 1990 to present their household waste for collection in line with the following requirements:
2. **Presentation – in relation to properties where no bin store is in use**
  - a. Properties where front or rear of property face onto a road – please place your refuse and recycling at the boundary of your property where it faces a road.
  - b. Properties where front or rear of property **don't** face onto a road – please place your refuse and recycling at the nearest road to your property.
  - c. Your Refuse and Recycling shall be presented no earlier than evening prior to the collection day and by 7am on the day of collection, your Refuse and Recycling remains the responsibility of the resident until it is collected even if scavenged.
  - d. Only the Refuse and Recycling as detailed in the Collection Calendar shall be presented on that respective day.
  - e. Only items placed in the Pink Sack, Black sack, Green or Yellow Box, Food Caddy, Garden Waste Wheeled Bin or Green sack will be collected.
3. **Presentation of Glass Recycling**
  - a. All glass waste shall be presented in the Green or Yellow Recycling Box.
  - b. All glass waste shall be cleansed before being presented in the Green or Yellow Recycling Box.
  - c. No glass waste shall be presented in the Pink sack, Black sack, Food Caddy, Garden Waste wheeled bin or green sack.
4. **Presentation of Garden Waste**
  - a. Garden Waste will only be collected as follows: -
    - i. In one of the Council subscription service green waste wheeled bins.
    - ii. In purchased Castle Point Borough Council green waste sacks.
    - iii. Twigs, hedge trimmings, branches and logs not able to be put in a green waste wheeled bin or Castle Point Borough Council green waste sacks, should be cut to 1meter (3') lengths and bundled together with either a Castle Point Borough Council green waste sack or biodegradable twine, maximum of two bundles per collection.
  - b. Garden waste shall not be presented in black sacks as part of the fortnightly black sack collection.
  - c. No garden waste shall be presented in the Pink sack, Black sack, Green or Yellow box or Food Waste Caddy.

## **5. Presentation of Food Waste**

- a. All food waste shall be presented in the food waste caddy.
- b. No food waste shall be presented in the Pink sack, Black sack, Green or Yellow Box, Garden Waste wheeled bin or green sack.

## **6. Presentation of Pink Sack**

- a. Only Paper, Card. Plastic and Cans can be placed in the Pink Recycling sack.
- b. Food packaging shall be cleaned of any food prior to placing in Pink Recycling sack.
- c. No Pink Sack recyclable item shall be presented in the Black Sack, Green or Yellow Box, Food Caddy, Garden Waste wheeled bin or green sack.
- d. No nappies or sanitary items are to be placed in the Pink Recycling sack.

## **7. Presentation of Black Sacks**

- a. Only items not able to be presented in the Pink Sack, Green or Yellow Box, Food Caddy, Garden Waste Wheeled Bin or Green Sack shall be presented in the black sack.

**Failure, without reasonable excuse, to comply with this Notice will result in a £80 Fixed Penalty Notice being served upon the person named in evidence or the person named as paying Council Tax for the property.**

**Failure to pay the Fixed Penalty Notice within the prescribed period will make you liable on summary conviction to a fine not exceeding Level 3 (£1000) on the standard scale.**
